"THE NATURAL FAMILY IN AN UNNATURAL WORLD"

44 For me, the most discouraging recent marriage statistic came from the Pew Research Center. As recently as 1990, the Pew researchers reported about two-thirds of the American public agreed that children were 'very important' to a successful marriage. However, today, only about one of three Americans believes this

"This 'delinking' of marriage and procreation negatively affects children. The overwhelming message of modern social research is that children predictably do best when they are raised by their two biological parents in a marriage-based home: this is one basis for the label, 'natural.' Any variation from this model—be it cohabitation, single parenting, step-parenting, or same-sex couple households—any variation leads predictably to higher risks for the children involved. These children will be more likely—on average—to do poorly in school; to use alcohol and mind-altering drugs; to attempt suicide; to run afoul of the law. They will be less likely to be healthy, happy, productive, and civicly-engaged adults. Marriage also predictably delivers a higher likelihood of *continued on page 8*

LEADERS WIN "LIFE PRIZES"

Dr. Alveda King and Marie Smith of Priests for Life, and Douglas Johnson and Jeanne Head of National Right to Life Committee, were among the six recipients of the 2009-2010 Life Prizes, in recognition of their achievement in "awakening the conscience of America to uphold and preserve the sanctity of human life through their leadership and advances in public advocacy, scientific research, outreach and public disclosure activities, legal action and other noteworthy achievements." Prize winners will share a \$600.000 award.

Niece of civil rights leader Dr. Martin Luther King, Jr., Alveda King has been called the face of the African American prolife movement. Dr. King is the director of African American Outreach of Priests for Life and addressed Glenn Beck's "Restoring Honor Rally" at the Lincoln Memorial in August. Marie Smith, wife of Congressman Chris Smith, is Director of Outreach of the Parliamentary Network for Critical Issues, which is affiliated with Priests for Life. Smith has made it her mission to identify, unite and strategize with pro-life groups, legislators and religious leaders worldwide.

Douglas Johnson has been called the indispensable man in helping to rally and guide pro-life forces in the U.S. Congress. As legislative director of the National Right to Life Committee, Johnson has been involved in the greatest pro-life victories of the past four decades. Jeanne Head is the U.N. representative of National Right to Life Education Trust. In that position, she has fought valiantly for the unborn at the world organization and other international forums.

The other recipients of the Norinne A. and Raymond E. Ruddy Memorial Pro-Life Prize are Kristen Hawkins, executive director of Students for Life, and the Terri Schiavo Life & Hope Network. REAL WOMEN OF CANADA CRITICIZES CANADIAN U.N. DELEGATION



In a release dated Nov 4, 2010, REAL Women of Canada, a WCF Partner, excoriated Canada's U.N. delegation for supporting a report by the U.N. Rapporteur promoting "a newly fabricated human right – the right of children to comprehensive sexual education from 'the early stages of life.'"

REAL Women notes the report advocates a "right' to sex education unfettered by parents or religion, as the report claims that sexual education has been obstructed by religion and that guilt feelings about eroticism could be abolished by way of a diminished parental involvement in children's sexual education. The report continually referenced the government's necessary role in providing 'better sexual lives' for young people. Sexual diversity, and gender rights, are also to be a part of sex education according to this report."

REAL Women wonders why Canada's Conservative government allowed its U.N. delegation to endorse the anti-family report, which was debated on October 25, 2010 at the General Assembly and was met with strenuous opposition from African, Latin American, and Caribbean nations, the Organization of Islamic Conference, Russia and the Holy See.

"It is intolerable that Canada should support such a shocking document which is clearly contrary to the views of most Canadians," REAL Women declared. It urged Canadians to contact the office of Prime Minister Stephen Harper to express their dismay in the strongest possible terms.

MIKE DUFF DISMISSES LESBIAN PARENTING STUDY

United Families International President Mike Duff more than held his own in an exchange with Kathy Young of the homosexual Human Rights Campaign on lesbian parenting. The forum was the website of ABC 15, the network's Phoenix affiliate.

Speaking of the so-called U.S. National



Longitudinal Lesbian Study by Dr. Nanette Gartrelle of the University of California at San Francisco, Duff revealed, "This study was commissioned and sponsored by a pro-homosexual group intent on advocating its agenda and seeking a vehicle to perpetuate its propaganda campaign..."

Duff disclosed: "It is basically a poll of lesbians' adult children (78 children over 20 plus years). It consisted of interviews who 'self-selected' to take part in the study. It is also a survey of children's opinions of themselves. It 'polls' on how lesbians perceive and rate their children in terms of a few parameters. Using such methodology means the results are virtually predetermined."

Duff noted that most of these studies of lesbian "parenting" compare children raised by lesbians to those from single-parent families, not to the children of intact, two-parent households – again, tilting the results. Duff: "Children learn about family life by observing crucial relationships up close: interactions between men and women, husbands and wives, mothers and fathers, and parents and children of the same and opposite sexes. Human experience and a vast body of social science research show that children do best in married, mother-father households. It is wrong to create fatherless or motherless families by design. The arrangement may gratify some adults, but is not in the best interests of children."

In one of its Weekly Briefings, Population Research Institute exposed the abortion lobby's attempt to present government subsidies for abortion and contraception as economic stimulus.

Us Into Prosperity," Steven W. Mosher and Colin Mason write that appearing on the nationally syndicated Bill Press Show, Planned Parenthood President Cecile Richards, "claimed that birth control is one of those issues that actually saves the government." In other words, every child not conceived or born is a tax-savings.

Mosher and Mason respond: "No one denies that it costs money to raise a child, of course, but those who do so are making a fundamental investment in the future. Children grow into adults, who not only contribute to the GDP by entering the workforce, but also contribute, using their own special gifts, to creating families, communities and societies. To view babies as economic liabilities, as Richards does, is not only dehumanizing: it makes no economic sense whatsoever."

With humanity hurtling toward Demographic Winter, Planned Parenthood is urging national suicide.

EUTHANASIA PREVENTION COALITION FINDS OPPOSITION TO EUTHANASIA RISING IN CANADA

For many years Euthanasia Prevention Coalition (a World Congress of Families Partner) has been analyzing Canadian survey results related to euthanasia and assisted suicide.

A recent Environics Group Survey shows that the EPC strategy not only convinced Canadian MPs to vote against legalizing euthanasia and assisted suicide, but has also helped to shift public opinion against



legalization in Canada. (Bill C-384, which would have legalized euthanasia and assisted suicide was defeated by 228 to 59 on April 21, 2010.) The survey on euthanasia was based on 2,025 Canadians questioned between September 15 – 22.

The research indicates that Canadians are concerned that if euthanasia were legal that it would negatively affect vulnerable people and that support for legalizing euthanasia is falling.

The poll found that:

-In 2010, 59% supported legalizing euthanasia, with 22% strongly supporting. By contrast, in 2009, 61% had supported legalizing euthanasia, with 25% strongly supporting.

-This year, 63% were concerned that the elderly would feel pressured to accept euthanasia to reduce health care costs. Last year, 56% shared the same concern.

-78% were concerned that a significant number of people who are continued on page 9

With a background in management and consulting, Alexey Komov is the Chairman of the upcoming "Moscow Demographic Summit: Family and Future of Humankind" (July 12-14, 2011), the world's first summit on the causes and

consequences of rapidly falling fertility.

Head of the WCF Representative Office in Russia and the CIS, Alexey is also the International Pro-Life Projects Coordinator of the Russian Orthodox Church.

Fluent in the four main European languages, Alexey has 17 years of international business experience and has previously worked in the areas of management and real estate consulting (founding partner of Integrity Consulting Boutique), general management in fast-moving consumer goods corporations, special events (congresses, exhibitions, large-scale concerts and racing championships), marketing and sales (Cushman & Wakefield - Big 4 in commercial real estate), business development (Zurich Financial Services - Fortune 500) and show business projects (organizing events for 5000-plus).

Alexey has an MBA (Open University, Business School, UK), an MA in US contemporary history (Moscow State Lomonosov University), and has studied business law (State University of New York at Albany) and theology (St. Tikhon Orthodox Humanitarian University).

Alexey is the author of the book "Stock Markets Regulation in the USA and Russia," published in 1998.

Andrea Minichiello Williams is a founder and currently CEO of both Christian Concern (formerly Christian Concern for Our Nation) and Christian Legal Centre, in the United Kingdom.

Andrea qualified as a barrister at the Inns of Court School of Law, after gaining a degree in Law and Italian from the University of

Wales in Cardiff, one of Britain's major teaching and research universities. She spent a year abroad studying in Italy, where she lived with her Italian family.

She excelled in advocacy and mooting at the Inns of Court School of Law and went on to her pupillage (apprenticeship to a barrister) in 2 Dr. Johnson's Chambers.

Andrea specialized in criminal and family law and practiced at the English Bar for eight years. She also did cases in the Old Bailey, England's Central Criminal Court and regularly appeared in the High Court

Andrea began her public policy work within the Lawyers' Christian Fellowship and developed the Public Policy Unit there.

Christian Legal Centre was founded in September 2007 and Christian Concern (then CCFON) separated from the LCF in July 2008 in order to pursue campaigning work without the strictures of charity law.

Andrea is frequently asked to comment on issues of importance in national media outlets. During the year she lived in Atlanta, Georgia, Andrea was involved in Women for Women, an abortion counselling ministry that reached out to women on the sidewalks facing crisis pregnancies. She was assigned 3 women who had been counselled out of having an abortion and was able to meet some of the babies that would otherwise have been killed.

Andrea is a wife and the mother of four children (7 to 15 years of age), and attends a small outreach church in central Haywards Heath.

NEW WORLD CONGRESS OF FAMILIES PARTNERS

Christian Concern (formerly Christian Concern for our Nation) seeks to introduce a Christian voice in law, media and government in the United Kingdom. It encourages churches and Christians to speak out on issues that matter.

In 2010, Christian Concern launched its "Not Ashamed" campaign as an opportunity for Christians across the country to declare their confidence that Jesus Christ is good news not only for individuals but for society as a whole.

"Not Ashamed" is about Christians living their faith in public. In Britain, there have been cases where employees have been told they cannot demonstrate their allegiance to Christ by wearing a cross, or come under pressure for speaking for Jesus at work.

On December 1, 2010, Christian Concern asked Christians across the nation to wear a cross to show their support for Christ and this campaign, and are praying that many opportunities will be created for Christians to share Jesus with their friends.

Not Ashamed Day will see the delivery of a "Declaration of Christian Hope for our Nation" to leading figures in public life.

The "Choose Life" initiative was launched by Christian Concern this year to help Christians speak with conviction and compassion about the sanctity of life.

Christian Concern's "Stop and Think" campaign is the first phase of this initiative. On the anniversary of the Abortion Act 1967 (October 27), the group held a prayer vigil outside Parliament and a service of lament and repentance in Westminster Abby, where Bishop Nazir-Ali spoke. Christian Concern intends to make its "Choose Life" campaign an ongoing activity.

Christian Concern responds to a wide range of policy issues. It won an important victory when a freedom of speech clause was inserted into the Racial and Religious Hatred Bill in 2006, without which Christians would have been prevented from preaching the Gospel. The Government was expected to win but lost by one vote after CC organized a campaign to protect freedom of speech. That was only the second time the Government had been defeated since 1997.

CC also led successful campaigns against the legalization of assisted suicide in 2006 and 2009.

Christian Concern remains very concerned that the Public Sector Equality Duty Act of 2010 (PSED) will be implemented in such a way that Christians organizations will be forced to choose between implementing the law's politically correct definitions of "sexual orientation," "gender" and religious belief, or losing public funding for vital projects.

CC has also created the Wilberforce Academy, a week-long public policy training program for aspiring Christian lawyers, politicians, journalists and business people.



Christian Concern is an offshoot of Christian Legal Centre. CLC is a legal action group that promotes Christian truth in the public arena and protects the freedom of Bible-believing Christians to speak the truth on matters such as life, marriage and the family, and to live their lives in accordance with their Christian beliefs.

participation by the leading scientists worldwide, professional demographers and researchers, and U.S. Senators and Congressmen, as well as the Russian Orthodox Church and government representatives. More than 1,000 are expected to attend.

"Reports and articles of the leading international scientists will be published as a separate book (after the Summit), in English, Russian and Spanish and distributed to leading universities and libraries all over the world.

"All this will help to attract media and public attention to the current crisis of the family and strategies to overcome it, and to counteract anti-family initiatives in Russia.

"Russia's pro-life and pro-family movements will be strengthened, showing the Russian government, politicians and also opponents that we have strong international support and are united to fight for the family. That is of paramount importance, due to increased threats and fierce attacks on traditional values in Russia and worldwide.

"The Moscow Demographic Summit of 2011 will be a great stimulus for further consolidation and active growth of the pan-Russian pro-family movement, which may culminate in World Congress of Families VII for 5,000 people in the Moscow Kremlin in 2014."

The Summit will also be the first World Congress of Families event in Russia.

With this conference, WCF will return to its roots. The possibility of a World Congress of Families was first discussed by International Secretary Allan Carlson, Prof. Anatoli Antonov (Moscow State Lomonosov University) and the late Viktor Medkov (also a professor at the Lomonosov University) in a chilly Moscow apartment in January 1995. Two years later, the first Congress was held in Prague in the Czech Republic.

health, wealth, longer life, and happiness to the women and men who take these vows."

"The central purpose of my book, The Natural Family, is to offer a fresh vision for the future; one unencumbered by tired language (such as the term, 'traditional family') and by negativism (such as the usual focus by family-advocates on what they oppose). The book also grounds this vision in the research findings of the biological and social science. My coauthor Paul Mero and I summarize our vision in two paragraphs. As you will note, restoring the bonds of marriage to procreation and of the family to the economy are central to our vision.

'We see a world restored in line with the intent of its Creator. We envision a culture—found both locally and universally—that upholds the marriage of a woman to a man, and a man to a woman, as the central aspiration for the young. This culture affirms marriage as the best path to health, security, and fulfillment. It casts the home built on marriage as the source of true political sovereignty, the fountain of democracy. It also holds the household framed by marriage to be the primal economic unit, a place marked by rich activity, material abundance, and broad self-reliance. This culture treasures private property in family hands as the rampart of independence and liberty. It celebrates the marital sexual union as the unique source of new human life. We see these homes as open to a full quiver of children, the source of family continuity and social growth. We envision young women growing into wives, homemakers, and mothers; and we see young men growing into husbands, homebuilders, and fathers."

"As you can see, The Natural Family: A
Manifesto is unabashedly pro-natalist. The so-called
'population bomb' was the last century's fixation,
misleading in its assumptions. The true challenge
facing the 21st century is demographic implosion, the
depopulation now found most acutely, in modern
industrial societies: yet spreading to all parts of the
globe. Only those nations that welcome and encourage
larger families built on marriage have viable futures, a
conclusion that underscores the importance of this
conference."

MARIJUANA LEGALIZATION DEFEATED IN CALIFORNIA – WCF OPPOSED BALLOT MEASURE



Crouse said in a prepared statement: "Over the past four decades, liberal ideas and values have often prevailed in the competition

with traditional values and ideas. My work documents the disastrous consequences suffered by several generations of our nation's children as a result of 40 years of policies based on the prevailing ideology and the shift away from Judeo-Christian values as the nation's moral touchstone."

Regarding Proposition 19, Shaw warned: "The research is clear: marijuana is the 'gateway drug,' meaning that users are susceptible to moving on to even more destructive drugs, like heroin and cocaine. Further, we know that legalization increases use. The Netherlands liberalized their drug laws and marijuana use among those 18-20 years of age increased from 15% in 1984 to 44% in 1986."

Among organizations represented at the press conference were the Drug Free America Foundation, Family Research Council (also a WCF Partner), the National Black Church Initiative, the National Sheriffs Association and Drug Watch International. On November 2, pro-drug referenda were also



defeated in Oregon, South Dakota and Arizona. Much of the drug lobby is funded by anti-family funder George Soros.

sick, disabled or elderly would be euthanized without their consent. Last year, 70% shared the same concern.

-71% believe that the government needs to place a greater priority on improving palliative care rather than legalizing euthanasia — versus 69% in 2009.

Compared to years past:

-Canadians are more concerned that people will feel pressured to accept euthanasia in order to reduce health care costs.

-Canadians are more concerned, that if euthanasia were legal, a significant number of people would be euthanized without their consent. This concern is a well-founded. A study that was published in May, 2010 found that 32% of euthanasia deaths in the Flanders region of Belgium were done without explicit request or consent.

-Increasingly, Canadians in all regions want the government to improve end-of-life care, rather than legalize euthanasia. In Quebec, where the government is attempting to find a consensus to legalize euthanasia through the backdoor, 60% preferred improving end-of-life care, instead.

MEMO TO CONSERVATIVES: IF WE LOSE MARRIAGE, WE LOSE EVERYTHING

EXCERPTS FROM A COMMENTARY BY WCF COMMUNICATIONS DIRECTOR DON FEDER PUBLISHED ON WORLD NET DAILY (AUGUST 13, 2010)

"Memo to conservative defeatists: Surrender on gay marriage is surrender on marriage – which is surrender on the family and, ultimately, surrender on civilization."

"This unwillingness to fight for the family, on which civilization depends, is another sign of the failure of modern conservatism.
The right can win a thousand

battles against big government and lose the war for America's future if it surrenders on marriage and the family.

America's social traumas – illegitimacy, juvenile crime, drug abuse, female-headed-households – can all be traced back to the decline of the family: which started with the Great Society in the '60s, accelerated with no-fault divorce in the '70s, continued with the rise of cohabitation, and reached its culmination with same-sex marriage.

Offering competing models, socially sanctioned, undermines heterosexual marriage. Two men engaged in what used to be described as unnatural acts, become the legal/moral equivalent of a man and woman (husband and wife), joined by faith and tradition, doing society's essential work of childbearing and childrearing.

Schools will teach that any living arrangement is as good as any other. Employers will be forced to provide 'family benefits' to same-sex couples, regardless of religious scruples.

The state will be required to place children with gay couples for adoption — depriving them of the father/mother role models necessary for successful adjustment. In Massachusetts, Catholic Charities ended its adoption program (the largest in the state), rather than submitting to placing children with



homosexuals, as required in the nation's first gay-marriage state."

"Homosexual activists (among the most driven ideologues on the planet) will insist that all churches perform same-sex ceremonies – and push for withdrawal of charitable tax-status of those that refuse. Hate-crime laws will be applied to the

ministers and priests who preach Leviticus or Romans 1: 26-27. In Europe and Canada, clerics have been hauled before human-rights tribunals for defending their faith from the pulpit."

"Unfortunately, many conservative intellectuals have lost sight of a crucial fact: American exceptionalism rests on three pillars – faith, family and freedom. Remove any one, and the entire structure collapses.

How can you have a strong economy without strong families? As economist Ludwig Von Mises noted, deferred consumption is necessary for capitalism to work. That means individuals willing to sacrifice for the future – and that means families.

Without the family, it doesn't matter how many times we defeat socialism (nationalized health-care, government take-over of business, soaring deficits, redistributionism), in the end, we lose — which is why the left has made same-sex marriage its priority, and why it is less tolerant of dissent here than anywhere else.

Conservatives who don't understand this, understand nothing."

IN MEMORIAM: DR MILDRED FAY JEFFERSON



On October 15, 2010, the unborn lost an articulate, impassioned, tireless champion with the death of Dr. Mildred Fay Jefferson at age 84.

Dr. Jefferson was a pioneer of the U.S. right-to-life movement. She was one of the founders of the National Right to Life Committee and served three terms as the organization's president.

She was also a founder, director and president of Massachusetts Citizens for Life. At the time of her death, Jefferson was president of the Right to Life Crusade. She was also active in Black Americans for Life.



Dr. Jefferson was the first black woman to graduate from the Harvard Medical School, the first woman admitted to be a surgical intern at Boston City Hospital and the first woman admitted to membership in the Boston Surgical Society. She taught surgery for several years at the Boston University School of Medicine.

In the early 1970s, Dr. Jefferson gave up a brilliant career in medicine to spend the next four decades fighting abortion.

Testifying before Congress in 1981, Jefferson declared: "I became a physician in order to help save lives. I am at once a physician, a citizen and a woman, and I am not willing to stand aside and allow the concept of expendable human lives to turn this great land of ours into another exclusive reservation where only the perfect, the privileged, and the planned have a right to live."



Raised in Texas during the era of Jim Crow, Jefferson often compared Roe. v. Wade to the pre-Civil War Dred Scott decision – another case where the U.S. Supreme Court denied the humanity of an entire class of people.

The recipient of 28 honorary degrees, Dr. Jefferson spoke and debated at college campuses and other forums across the United States. She was widely considered the most eloquent spokesman for the right-to-life movement.



Whenever he saw her, President Ronald Reagan exclaimed, "There is my favorite doctor." Reagan credited an appearance by Jefferson on the PBS show "The Advocates" with helping him to change from a prochoice governor of California to a fervent right-to-lifer.
