DEMOGRAPHIC DIFFERENTIALS IN LIFE SATISFACTION AND WELLBEING

Radoslaw Antczak

Inequalities in subjective wellbeing using life satisfaction and evaluated time index

The author compares momentary and recall life evaluations, showing significant differences in the level of wellbeing depending on the applied measure.

Wellbeing inequality among different demographic groups in Turkey

The study shows that wellbeing varies significantly across households in Turkey which have different demographic characteristics and socio-economic statuses.

The Mexican recipe for life satisfaction: gender differences in the role of age and education

The author shows that educational attainment increases life satisfaction of Mexican women, while income neutralises the effects of education for Mexican men.

Izabela Grabowska

Multidimensional quality of life of persons with and without disabilities in Poland – a comparative approach

The authors show that lower multidimensional QoL was observed for persons with disabilities in Poland compared to those without disabilities, except for education.

Guogui Huang & Fei Guo

The role and wellbeing of female family care givers in the provision of aged care in China

This study suggests that an increasing proportion of Chinese females are providers of aged-care givers at home, which negatively affects their health/wellbeing.

Satisfied life years in ex-Yugoslav republics

The author shows that low economic satisfaction affects on overall wellbeing in ex-Yugoslavia, while happiness is associated with good health and personal relationships.

Kazuma Sato

Unhappy obesity and happy obesity: a comparative study of the United States and China

The author indicates that while obesity has negative effects on individuals in the United States, it has a positive effect on the individuals in China.

Maia Sieverding

Determinants of subjective wellbeing over the life course in Egypt

The authors find high levels of poor subjective wellbeing among the Egyptian population, with age- and gender-specific predictors of suffering poor wellbeing.

Gender differentials in wellbeing in Italy

The authors say that measures of wellbeing in Italy show a notable gender gap, aggravated by the economic crisis.

Understanding women's wellbeing in Turkey: trends and determinants of women's satisfaction with life

Life satisfaction of Turkish women: What matters? Education, job, income or family & children?

MIGRATION AND WELLBEING

Satisfaction, wellbeing and educational attainment: how do children of immigrants perform compared to natives?

In the Italian context no differences emerge between native and immigrant children in subjective wellbeing at school, both with schoolmates and teachers.

Contacts with children and subjective wellbeing: do the relationships differ for older migrants and natives in Europe?

The authors found that contact between older parents and adult children is similar among migrants and natives. Southern Europeans benefit the most from more contact.

The wellbeing of forced immigrants in Germany

In Germany, new refugees' wellbeing is lower than that of natives, whilst second-generation migrants are significantly better off than natives.

A comparison of refugees' health determinants in Germany and Austria

Refugees in Germany less often report good health than in Austria, which might partly reflect initially limited access to health-care in Germany.

Mental wellbeing of Syrian, Iraqi and Afghan refugees in Austria: evidence on the prevalence of anxiety disorder and depression

The authors show that rates of moderate to severe depression are twice as high among the refugee population as among the Austrian resident population.

HEALTH AND WELLBEING OVER THE LIFE COURSE

Is providing support to older parents detrimental to adult children's quality of life? Evidence from selected European countries. The authors show that providing care to parents lowers SWB, mostly among women in western and central-eastern European countries.

Heather Booth, Steffen Peters & Mahin Raissi

Socio-demographic homophily in friendship networks and self-rated health in later life.

The authors show that multidimensional homophily in non-kin networks is positively associated with self-rated health among older Australians.

Sirinya Kaikeaw , J. Rittirong & Sureeporn Punpuing

Health expectancy among older people in Thailand

The authors show that Thai older people live longer but with poor health and disabling conditions, suggesting the expansion of disability.

The importance of dyadic functionality and social resources on ageing well

Longitudinal interviews show the ambivalence of successful ageing norms for elderly couples, as dyadic functionals, emotional unity is crucial for ageing well.

The effects of socio-economic factors on depression and perceived health status (PHS) among a cohort of young people (15-24) in South Africa: evidence from the National Income Dynamics Study (NIDS) waves 1-5. The authors find that completion of secondary and tertiary education reduces the chances of being depressed and increases the chances of reporting bad PHS.

Interrogating age-specific wellbeing; the case of street children in Nigeria

Increasing numbers of children in northern Nigeria become almajiri suffering severe deprivation in nutrition, education, health and material possession.

Cosmo Strozza, Patrizio Pasqualetti, Viviana Egidi, Claudia Loreti, Federica Vannetti, Claudio Macchi & Luca Padua

Health profiles among nonagenarians from Mugello district (Tuscany, Italy) and their socio-economic characteristics. This study highlights four latent-groups labelled according to the health conditions of the nonagenarians populating them: "healthy", "semi-autonomous senile", "un-healthy" and "non-testable".

The effect of antimalarial campaigns on child mortality and fertility in sub-Saharan Africa

The authors show that African bed net distribution campaigns has temporarily increased fertility in spite of increased contraceptive use and reduced fertility preferences.

Number of children and later life health in 20 countries

The authors are showing that the effect of low or high numbers of children on different health measures varies by national context.

Thananon Buathong, Raya Muttarak, Roman Hoffmann & Montakarn Chimmamee

Fertility patterns and subjective wellbeing among low-income households: evidence from Thailand

A higher number of children has a positive effect on life satisfaction, but this effect strongly varies by gender, age and education level.

Andrew E. Clark, Conchita D'Ambrosio & Nicholas Rohde

Prenatal economic shocks and birth outcomes in UK cohort data

The authors find that mother-reported financial problems during the first 18 weeks of gestation are associated with births of lower weight and smaller head circumference.

Marital status and wellbeing in later life: does the timing of events affect their outcomes? Evidence from Israel.

Marital status is associated with economic and emotional wellbeing later in life; married people enjoy highest levels while long-divorced and never-married have the lowest.

Do parenthood and partnership protect life satisfaction in the old age?

The author shows that life satisfaction of parents in Switzerland is shaped by the economic costs of parenthood and the work-family conflict.

Natalie Nitsche & Mikko Myrskylä

Changes in self-rated health around the time of childbirth among couples in Europe. Changes in parental self-rated health around the time of childbirth vary across Europe, and are partly mediated by the partner's health.

Ognjen Obućina, Sven Drefahl & Siddhartha Aradhya

Partner choice and mortality in Sweden

The analysis shows that there is an association between mortality risk and intermarriage among men in Sweden, whereas we find no such evidence for women.

Somefun D. Oluwaseyi

The effect of family and neighbourhood social capital on youth mental health in South Africa

Our results confirm the independent effect of neighbourhood characteristics on youth mental health and did not support family social capital as being protective for developing depression.

Singles in the city: happily ever after?

This study compares subjective wellbeing across household types and shows why "the happy young single" is not better off than "the lonely elderly person".

Jiixin Shi, José Manuel Aburto, Pekka Martikainen & Alyson van Raalte

Beyond differences in means: rising mortality stratification among income groups in Finland, 1996-2014

The new measurement proposed by the authors yields an upward trend of mortality stratification between income groups in Finland since 1996.

Education at any cost? About the effects of secondary-track mismatch on pupils' wellbeing in Germany

The author demonstrates that pupils in the academic schooling track without a teacher's recommendation display persistently lower abilities and wellbeing than their peers.

The impact of change of employment status on quality of life indicators. A longitudinal study on young Italian people by using traditional and social media data

The transitions from and to the Neet condition have a significant impact on wellbeing and quality of life of young Italians.

Agnieszka Chłoń-Domińczak, Iga Magda & Paweł Strzelecki

Mothers' life-course work and career choices and intergenerational ties at older age

Using SHARE data, the authors analyse womens' economic activity over the life course and intergenerational relations in later life.

Demographic transitions, changing family structures and their impact on economic inequalities – evidence and policy implications

Socio-demographic trends have collectively had a limited overall impact on income inequality, though some groups have fared worse than others.

Slow down before you stop: the effect of the 2010 French pension reform on older teachers' sick leaves

The authors show that increasing the minimum retirement age has increased the short sick leaves taken by school teachers in France.

Deconstructing gender differences in experienced utility among older adults in the developing world: the roles of time use and activity-specific affective experiences

Female disadvantage in old-age experienced wellbeing in five developing countries is more attributable to gender differences in activity-specific affects than to time use.

Consumer credit and life satisfaction: the role of financial literacy and financial advice

Using consumer credit makes German households unhappy, but the distress disappears for those who are financially literate and use financial advice simultaneously.

Gender, education and income inequality on the Cameroon labour market

Ashish Singh & Laeek Siddiqui

Indices for measuring socioeconomic inequality in longevity: theory and an application to India

The poster shows that India suffers from substantial socioeconomic inequalities in longevity with economically, demographically and socially disadvantaged groups having severe under-representation in longevity.

Jonas Vossemer & Anna Baranowska-Rataj

Unemployment and the wellbeing of families: the mediating role of household income and the quality of relationships

Only a small part of the negative effect of unemployment on the wellbeing of the partner is due to poorer relationship quality.
